## NOTICE TO ALL EMPLOYEES

### REMEMBER TO TELL YOUR EMPLOYER ABOUT YOUR INJURY

1. ANY EMPLOYEE WHO SUFFERS A WORK RELATED INJURY MUST REPORT IT IMMEDIATELY TO HIS/HER SUPERVISOR.
2. TO ENSURE THAT YOUR MEDICAL TREATMENT WILL BE PAID FOR BY THE UNIVERSITY OF PENNSYLVANIA'S WORKERS' COMPENSATION PROGRAM, YOU MUST SELECT AND VISIT ONE OF THE LICENSED PHYSICIANS OR PRACTITIONERS OF THE HEALING ARTS LISTED BELOW FOR A 90 DAY PERIOD FROM THE FIRST VISIT IF YOU NEED TREATMENT FOR YOUR WORK RELATED INJURY.
3. AFTER THIS 90 DAY PERIOD, IF YOU STILL NEED TREATMENT, YOU MAY CHOOSE TO GO TO ANOTHER LICENSED PHYSICIAN OR PRACTITIONER OF THE HEALING ARTS FOR TREATMENT. YOU MUST NOTIFY YOUR EMPLOYER OF YOUR DECISION WITHIN FIVE (5) DAYS OF YOUR VISIT TO THAT INDIVIDUAL.
4. DIRECT YOUR INQUIRIES TO THE UNIVERSITY'S THIRD PARTY ADMINISTRATOR FOR WORKERS' COMPENSATION CLAIMS:
